RESOLUTION NO. SP- 978 - 3-98

A RESOLUTION AUTHORIZING HIS HONOR, ISMAEL A. MATHAY, JR., CITY MAYOR, QUEZON CITY, TO SELL TO HONORABLE MOISES S. SAMSON, AN INCUMBENT CITY COUNCILOR, QUEZON CITY, THE MOTOR VEHICLE ASSIGNED TO HIM PARTICULARLY DESCRIBED AS TOYOTA TAMARAW FX WITH PLATE NO. SEK 747 AT PRICE TO BE DETERMINED BY THE CITY APPRAISAL COMMITTEE, SUBJECT TO EXISTING AUDITING RULES AND REGULATIONS.

WHEREAS, all City Councilors have been issued motor vehicles by the Quezon City government for their official use or to be use in connection with exercise of their official functions;

WHEREAS, a certain motor vehicle specifically described as follows:

was issued and assigned to Honorable Moises S. Samson, for his official use in connection with the exercise of his official functions as City Councilor and Majority Floor Leader;


WHEREAS, Quezon City Council Resolution No. 8630, S-71, authorizes the sale to incumbent officials, officers and employees of the Quezon City government of vehicles presently assigned to them, should they be willing to purchase the same at their appraise value at the time of the sale; Provided, that taxes payable and due the government shall be shouldered by the purchaser;

WHEREAS, to sell the assigned motor vehicle to the incumbent city official who had been using the same during his term as City Councilor of Quezon City would be beneficial and advantageous to the Quezon City government considering the amount to be recovered out of the funds used in acquiring the said vehicle;

NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, His Honor, Ismael A. Mathay, Jr., City Mayor, Quezon City, to sell to Honorable Moises S. Samson, an incumbent City Councilor of Quezon City the motor vehicle assigned to him particularly described as Toyota Tamaraw FX SEK-747 at a price to be determined by the City Appraisal Committee, subject to existing auditing rules and regulations.
