A RESOLUTION CONFIRMING THE APPOINTMENT OF DR. MARIA PAZ DIMAISIP UGALDE, AS CITY HEALTH OFFICER III (CITY GOVERNMENT DEPARTMENT HEAD III) OF QUEZON CITY.

WHEREAS, His Honor, Ismael A. Mathay, Jr., City Mayor of Quezon City, in his letter dated July 29, 1998, endorsed to Her Honor, Connie S. Angeles, City Vice Mayor and Presiding Officer, Quezon City Council and to the Honorable Members of this August Body, the appointment of Dr. Maria Paz Dimaisip Ugalde as City Health Officer III of Quezon City, for prompt and favorable action;


