A RESOLUTION AUTHORIZING THE INSTALLATION OF A MARKER BELOW THE PICTURE OF FORMER VICE-MAYOR JORGE L. BANAL AT THE CARLOS ALBERT HALL LOBBY-GALLERY WITH THE SPECIFIC INSCRIPTIONS.

WHEREAS, as a form of recognition for their services to the City and as a manner of a historical marker, the pictures of all persons who occupied the Vice-Mayorship of the City are installed on the lobby-gallery of the Carlos Albert Hall with bronze marker, whose information of their incumbency are inscribed, and placed individually below the corresponding pictures;

WHEREAS, in faithful observance of the practice, which in light of the long years of its strict adoption, has evolved into a tradition, the picture of Honorable Jorge L. Banal, Vice-Mayor from April 7 to June 30, 1998 has been installed on the aforementioned picture gallery together with a bronze marker which was in production before the introduction of Resolution No. SP-962, S-98 and was installed on June 26, 1998 before the aforementioned Resolution was signed;


WHEREAS, Resolution No. SP-962, S-98 requires the approval of the City Council before any marker could be installed in the aforementioned gallery;


NOW, THEREFORE,
