A RESOLUTION AUTHORIZING HIS HONOR, ISMAEL A. MATHAY, JR., CITY MAYOR, QUEZON CITY, TO SELL TO MRS. EVELYN B. MERCADO, WIFE OF THE LATE CITY TREASURER ALFREDO D. MERCADO, THE MOTOR VEHICLE ASSIGNED TO HIM PARTICULARLY DESCRIBED AS GRAY TOYOTA COROLLA AT A PRICE TO BE DETERMINED BY THE CITY APPRAISAL COMMITTEE, SUBJECT TO EXISTING AUDITING RULES AND REGULATIONS.

WHEREAS, all City Government Department Heads have been issued motor vehicles by the Quezon City government for their official use;

WHEREAS, Quezon City Council Resolution No. 8630, S-71, authorizes the sale to incumbent officials, officers and employees of the Quezon City government of vehicles presently assigned to them should they be willing to purchase the same at their appraised value at the time of the sale; Provided, that taxes payable and due the government shall be shouldered by the purchaser;


