RESOLUTION NO. SP- 1 2 7 4 , S-99

A RESOLUTION AUTHORIZING THE HONORABLE VICE MAYOR CONNIE S. ANGELES, TO ENTER INTO NEGOTIATED CONTRACTS AMOUNTING TO ONE MILLION PESOS (P1,000,000.00) BELOW FOR ANY AND ALL COMMUNITY BASED PROJECTS AND FURTHER AUTHORIZING THE HONORABLE VICE MAYOR TO SIGN THE SAME IN BEHALF OF THE CITY GOVERNMENT, THE AMOUNT NECESSARY THEREFOR TO BE TAKEN FROM THE ANNUAL BUDGET OF THE OFFICE OF THE VICE MAYOR.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Honorable Vice Mayor Connie S. Angeles to enter into negotiated contracts amounting to One Million Pesos (P1,000,000.00) below for any and all community based projects and


