RESOLUTION NO. SP-2430, S-2004

A RESOLUTION URGING CONGRESS TO ENACT A LAW WHICH WILL PROVIDE FOR THE INCLUSION OF THE SERVICES RENDERED IN THE BARANGAY LOCAL GOVERNMENT IN THE COMPUTATION ofTHE LENGTH OF. SERVICE 0FGOVERNMENT PERSONNEL OR **EMPLOYEE** WHO RETIRES UNDER THE PROVISIONS OF EXISTING RETIREMENT LAWS.

WHEREAS, it appears that under the provisions of existing retirement laws, the services rendered in the barangay local government is not included in the computation of the length of service of a government personnel or employee who retires upon reaching the allowable retirement age or having rendered the required length of services in the government;

WHEREAS, it is rather unfair to exclude the services rendered in the barangay in the computation of the length of services for retirement purposes, for the reason that the amount which the retiree will receive upon his retirement will correspondingly increase if such services in the barangay is otherwise included in the computation of the length of service for retirement purpose;

WHEREAS, there is a felt need to enact the necessary legislation intended to correct or remedy this apparent inequity in the computation of said length of services for retirement purpose.
