RESOLUTION NO. SP- **2435**, S-2003

A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE FAMILY AND SURVIVING HEIRS OF THE LATE KAGAWAD BENJAMIN AGUILAR OF BARANGAY TANDANG SORA IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00) TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2004 ANNUAL BUDGET OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.

WHEREAS, former Barangay Kagawad Benjamin Aguilar of Barangay Tandang Sora, this City, died of natural cause last January 10, 2002;

WHEREAS, the late Barangay Kagawad Aguilar has faithfully and unselfishly served his constituents in Barangay Tandang Sora for an intermittent period from October 1976 to 1981 and from 1989 up to the time of his demise;


WHEREAS, the selfless dedication and exemplary services of the late Kagawad Aguilar deserves appreciation by way of granting of financial assistance to alleviate the plight of his bereaved family as a result of his death and as a token of gratitude from the City government.


NOW THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to grant, as it does hereby grant, financial assistance to the family and surviving heirs of the late Benjamin Aguilar, a former Kagawad of Barangay Tandang Sora in the amount of Thirty Thousand Pesos (P30,000.00) to be charged against the appropriation for Grants, Subsidies and Contributions in the 2004 Annual Budget of the City Mayor or from any available funds of the City Treasury.
