A RESOLUTION STRONGLY URGING HIS HONOR, CITY MAYOR FELICIANO R. BELMONTE, JR., TO DIRECT THE INSTALLATION OF STREET LIGHTS ALONG A. BONIFACIO AVENUE AND PAINTING OF PEDESTRIAN LANES AT SELECTA DRIVE CORNER A. BONIFACIO AVENUE AND BALINGASA STREET CORNER A. BONIFACIO AVENUE, QUEZON CITY.

WHEREAS, section 458 (a)(5)(v) of RA No. 7160, otherwise known as the Local Government Code of 1991 states that, "the sangguniang panlungsod, as the legislative body of the city, shall enact ordinances, approve resolutions and appropriate funds  $x \times x$ , Regulate the use of streets, avenues, alleys sidewalks, bridges, parks and other public places approve the construction, improvement, repair and maintenance of the same,  $x \times x$ ;

WHEREAS, there are numerous pedestrian-related accidents and criminal incidents especially during night time, such as snatching, hold-ups, etc. at Selecta Drive corner A. Bonifacio Avenue, Quezon City, hence, an urgent need for the painting of pedestrian lanes and likewise the installation of street lights along A. Bonifacio Avenue, Quezon City,

WHEREAS, it is imperative for the City government to immediately introduce the appropriate solution to the problem mentioned in the immediately preceding paragraph hereof.
