WHEREAS, a set of rules of procedure is a fundamental necessity in a deliberative body such as the City Council (Sangguniang Panlungsod) to prescribe the organization of the sangguniang and the election of the officers, as well as the creation and election of chair-persons and members of standing committees; the order and calendar of business for each session; the legislative process on the enactment and approval of ordinances and adoption of resolutions; the parliamentary procedures which include the conduct of members during sessions; the discipline of members for disorderly behavior and absences without justifiable cause for four (4) consecutive sessions;

WHEREAS, conformably with Section 50 of R.A. 7160, the Local Government code of 1991, the City Council is mandated to update its existing Internal Rules of Procedure to be abreast with the changing times and facilitate legislative proceedings.



## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to adopt, as it does hereby adopt, the Internal Rules of Procedure of the 16<sup>th</sup> Council of Quezon City.

RESOLVED, FURTHER, that all resolutions, rules and policies or parts thereof which are inconsistent with any provisions hereof are hereby repealed and modified accordingly.
