WHEREAS, the victory of Atty. Persida Rueda Acosta, has brought honor and glory to the Filipino people particularly to the people of Quezon City,


WHEREAS, the achievement of Atty. Persida Rueda Acosta is worthy of emulation by the people of Quezon City.
