WHEREAS, the victory of the Quezon City Chamber of Commerce and Industry (QCCCI) has brought honor to the people of Quezon City;


WHEREAS, the achievement of the Quezon City Chamber of Commerce and Industry (QCCCI) is worthy of emulation by the people of Quezon City.
