RESOLUTION URGING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR. TO CONSTRUCT AND INSTALL FOUR (4) ADDITIONAL STREETLIGHTS ALONG LIWANAG STREET, BARANGAY OLD BALARA, QUEZON CITY RELATIVE TO THE ON GOING CRIME PREVENTION PROGRAM OF THE SAID BARANGAY.
