RESOLUTION NO. SP-2716, S-2004

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR FELICIANO R BELMONTE, JR., QUEZON CITY, TO DISPOSE OF THE PROPERTY OWNED BY THE CITY GOVERNMENT DESCRIBED AS LOT 64-A, PSD-10962 (ASPRER PROPERTY) CONSISTING OF THIRTY THOUSAND SQUARE METERS (30,000 SQ. M.) COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED 49628 OF THE REGISTRY OF DEED OF QUEZON CITY, TO BE SOLD TO THE ACTUAL AND QUALIFIED BENEFICIARIES AT FOUR HUNDRED FIFTY PESOS (P450.00) PER SQUARE METERS.

WHEREAS, the actual occupants of said property have formed themselves into an association known as Asosasyon ng Piriagkaisang Residente ng Asprer, Inc., represented by their President, Mr. Armando A. Alboladora.
