A RESOLUTION REQUESTING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR., TO ALLOCATE AN AMOUNT NECESSARY FOR THE CONSTRUCTION OF A MULTI-PURPOSE HALL AND PELOTA COURT AT REMARVILLE SUBDIVISION LOCATED AT BARANGAY BAGBAG, QUEZON CITY, AS PER ATTACHED PLANS, PROGRAMS OF WORK AND DETAILED ESTIMATE BY THE OFFICE OF THE CITY ENGINEERING DEPARTMENT.
