RESOLUTION NO. SP.2728, S-2004

A RESOLUTION STRONGLY URGING THE SECRETARY OF TRANSPORTATION AND COMMUNICATION TO STRICTLY IMPLEMENT THE PROVISIONS OF EXISTING LAWS GRANTING A TWENTY PERCENT (20%) DISCOUNTS IN TRANSPORTATION FARE TO STUDENTS AND SENIOR CITIZENS.
