RESOLUTION NO. SP- 2734, \$12905

A RESOLUTION AUTHORIZING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, QUEZON CITY, TO NEGOTIATE FOR THE ACQUISITION OF PORTIONS OF VARIOUS PARCELS OF LAND TO BE USED AS BARANGAY ROAD APPROXIMATELY FOUR HUNDRED (400) METERS WIDE BY ONE HUNDRED (100) METERS LONG WITH LIMITS FROM PHILAND ROAD EXTENSION TO THE OLD EXISTING BARANGAY ROAD AT PINGKIAN TRAVERSING FOUR (4) LOTS WHICH WILL SERVE AS A SHORT CUT ROUTE TOWARDS TANDANG SORA VIA PHILAND EXTENSION.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Honorable Feliciano R. Belmonte, Jr., City Mayor, Quezon City, to negotiate for the acquisition of portions of various parcels of land to be used as barangay road approximately four hundred (400) meters wide by one hundred (100) meters long with limits from Philand Road Extension to the old existing barangay road at Pingkian traversing four (4) lots which will serve as a short cut route towards Tandang Sora via Philand Extension.
