RESOLUTION NO. SP- **2739**, S-2005

A RESOLUTION URGING THE CITY MAYOR, HONORABLE FELICIANO R. BELMONTE, JR., TO GRANT FINANCIAL ASSISTANCE IN THE AMOUNT OF TEN THOUSAND PESOS (P10,000.00) TO THE FAMILY OF THE LATE BSDO FRANCISCO RAMOS OF BARANGAY VETERANS VILLAGE, QUEZON CITY, TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS IN THE 2005 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR.

WHEREAS, BSDO Francisco Ramos died on October 22, 2004 due to cardiac arrest;

WHEREAS, under Ordinance No. NC-228, S-91, "PROVIDING FOR BURIAL BENEFITS FOR BARANGAY OFFICIALS AND REGULAR MEMBERS OF BARANGAY TANOD BRIGADES AND APPROPRIATING NECESSARY FUNDS THEREFOR" the heirs of all deceased Barangay officials, including barangay tanods, are entitled to financial assistance;

WHEREAS, at the time of death, the deceased had served Barangay Veterans Village as BSDO for more than three (3) years;

WHEREAS, the late BSDO Ramos had served Barangay Veterans Village, this City faithfully and well and his dedicated services to the community have redounded to the great benefit of the residents thereat and therefore, deserves the recognition and appreciation of the city as a whole;

WHEREAS, it is only fitting and proper to grant financial assistance to the surviving members of the family of the deceased.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby urge, Honorable Feliciano R. Belmonte, Jr, to grant financial assistance in the amount of Ten Thousand Pesos (P10,000.00) to the family of the late BSDO Francisco Ramos of Barangay Veterans Village, Quezon City, to be charged against the appropriation for Grants, Subsidies and Contributions in the 2005 Annual Budget of the Office of the City Mayor.
