A RESOLUTION URGING QUEZON CITY MAYOR FELICIANO R. BELMONTE, JR. TO GRANT FINANCIAL ASSISTANCE TO THE VICTIMS OF THE FIRE THAT OCCURRED ON DECEMBER 26, 2004 AT MARGARITA STREET, BARANGAY GULOD, QUEZON CITY (10)TEN FAMILIES. COMPRISING  $\mathbf{OF}$ HOMEOWNERS/RENTERS/SHARERS AT TWO THOUSAND PESOS (P2,000.00) EACH IN THE TOTAL AMOUNT 0FTWENTY THOUSAND PESOS (P20,000.00) TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUND OF THE CITY TREASURY.
