RESOLUTION NO. SP- 2768, S-2005

A RESOLUTION URGING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR., TO ALLOCATE THE AMOUNT OF ONE MILLION EIGHT HUNDRED SEVENTY-FOUR THOUSAND SIX HUNDRED EIGHTY-SIX PESOS (P1,874,686.00) FOR THE CONSTRUCTION OF A TWO-STOREY MULTI-PURPOSE HALL FOR THE SAMAHAN NG MGA SENIOR CITIZENS NG FAIRVIEW, INC., REPRESENTED BY THEIR PRESIDENT, MRS. PAZ C. VILLORIA, LOCATED AT BARANGAY GREATER FAIRVIEW, QUEZON CITY TO BE TAKEN FROM THE INFRASTRUCTURE FUND OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.

WHEREAS, there is an urgent need to construct a multi-purpose hall in order to serve the needs of the Senior Citizens in the area, as an excellent venue for the wide variety of activities and programs of the barangay with the different non-government organizations;

WHEREAS, the Samahan ng mga Senior Citizens ng Fairview, Inc., Barangay Greater Fairview, Quezon City, represented by their President, Mrs. Paz C. Villoria, has petition the City government for the construction of a multi-purpose hall in their area;

WHEREAS, the Department of Engineering has prepared the plans, programs of work and the detailed estimate of the proposed projects.
