RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO DIGITEL TELECOMMUNICATIONS PHILIPPINES, INC. (DIGITEL) THROUGH ITS AUTHORIZED REPRESENTATIVE MR. JOHN JOEY T. TERRENAL, VICE PRESIDENT, NETWORK PLANNING AND DEVELOPMENT DIVISION DIGITEL FOR THE CONSTRUCTION AND OPERATION OF CELL SITES AT TWO LOCATIONS, ALL IN QUEZON CITY.

WHEREAS, Digital Telecommunications Philippines, Inc., (DIGITEL) is applying for the Special Use Permit for the construction and operation of Cell Sites located at two locations, all in Quezon City, to wit;

1. Sta Maria Construction's Lot -- 103 Commonwealth Ave. Fairview, Quezon City
2. Pacific Corporation Center -- 131 West Avenue, Quezon City

WHEREAS, the operation of the said Cell Sites will serve to promote public welfare and economic development through the projected increase of employment opportunity and business opportunity in Quezon City,

WHEREAS, in accordance with the provision of Article VII, Section 2 (h) Ordinance No. SP-918. S-2000, and its implementing rules and regulations, a special use permit is required for Cell Sites to which the proposed project falls under.
