RESOLUTION NO. SP- **2776**, S-2005

RESOLUTION RATIFYING THE MEMORANDUM OF AGREEMENT ENTERED INTO BY AND BETWEEN THE QUEZON CITY GOVERNMENT, BARANGAY BAGUMBAYAN AND MANILA WATER COMPANY, INC. FOR THE REPLACEMENT/ CONSTRUCTION OF ACP PIPELINES LOCATED IN BARANGAY BAGUMBAYAN.

Introduced by Councilors ANTONIO E. INTON, JR., ELIZABETH A. DELARMENTE, JOSEPH P. JUICO, WINSTON "Winnie" T. CASTELO, JULIAN M.L. COSETENG and EDCEL B. LAGMAN, JR.

WHEREAS, Barangay Bagumbayan has proposed to replace the existing 100 mm diameters pipelines along Calle Industria going to San Roque Street, Quezon City, due to its defective state;

WHEREAS, the Manila Water Company, Inc., has approve the proposal of the Barangay Bagumbayan;

WHEREAS, the replacement of the existing pipeline would involve pipe laying with a total length of 1,160 linear meters and the interconnection thereof to a 600mm diameter pipe at E. Rodriguez Jr. Avenue (C-5), including the looping of an existing 75mm diameter pipe at San Jose Street, Barangay Bagumbayan;

WHEREAS, the Quezon City Local Government, Barangay Bagumbayan and Manila Water Company, Inc., have agreed to share the total cost of the project.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to ratify, as it does hereby ratify, the Memorandum of Agreement entered into by and between the Quezon City
