A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE FAMILY AND SURVIVING HEIRS OF THE LATE BARANGAY CAPTAIN ARTURO RIVERA ISON OF BARANGAY BATASAN HILLS, QUEZON CITY IN THE AMOUNT OF THIRTY THOUSAND PESOS (00,000,0ET) TO BECHARGED AGAINST THE APPROPRIATION SUBSIDIES FOR GRANTS. AND CONTRIBUTIONS UNDER THE 2005 ANNUAL BUDGET OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.
