RESOLUTION NO. SP- **2784**, S 2005

A RESOLUTION AUTHORIZING HIS HONOR, CITY MAYOR FELICIANO R. BELMONTE, JR., TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH BARANGAY NAYONG KANLURAN, QUEZON CITY, FOR THE DONATION OF LOT 1, BLOCK W-7, PORTIONS OF LOT B AND ROAD LOT 9, WITH A TOTAL AREA OF SIX HUNDRED SIXTEEN SQUARE METERS AND FIFTY SQUARE DECIMETERS (616.50 SQ. M.) SITUATED IN BARANGAY NAYONG KANLURAN, QUEZON CITY.

WHEREAS, the Quezon City government is the owner of a parcels of land covered by Transfer Certificates of Title Numbered RT-71782 and 267513 located at Barangay Nayong Kanluran, Quezon City with a total area of Six Hundred Sixteen Square Meters and Fifty Square Decimeters (616.50 Sq. M.);

WHEREAS, there are barangay structures already existing in the area such as the Barangay Day Care Center and Satellite Office of the late Congressman Reynaldo A. Calalay;

WHEREAS, the said barangay is now soliciting the benevolence and assistance of the City Mayor and of the Sangguniang Panlungsod to allow them to acquire the said property as Barangay Site.

Belmonte, Jr., to enter into a Memorandum of Agreement with Barangay Nayong Kanluran, Quezon City, for the donation of Lot 1, Block W-7, portions of Lot B and Road Lot 9, with a total area of Six Hundred Sixteen Square Meters and Fifty Square Decimeters (616.50 sq. m.) situated in Barangay Nayong Kanluran, Quezon City.
