RESOLUTION NO. SP- 2794, S-2005

RESOLUTION URGING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR., TO ALLOCATE THE AMOUNT OF ONE MILLION EIGHT HUNDRED SEVENTY FOUR THOUSAND SIX HUNDRED EIGHTY-SIX PESOS (P1,874,686.00) FOR CONSTRUCTION OF A TWO-STOREY MULTI-PURPOSE HALL FOR THE SENIOR CITIZENS ASSOCIATION TALANAY, CHAPTER B-1-2, LOCATED AT BARANGAY BATASAN HILLS, QUEZON CITY, TO BE TAKEN FROM THE INFRASTRUCTURE FUND OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.
