WHEREAS, it is the inherent power of the State to impose and collect taxes for public purposes;

WHEREAS, Republic Act 7160 otherwise known as the Local Government Code of 1991 granted the local government units (LGU's) to impose and collect taxes;

WHEREAS, the Department of Interior and Local Government, National Capital Region in coordination with the Metro Manila Liga ng mga Barangay launched recently the "Suyod Buwis sa Barangay";

WHEREAS, the said project is aimed to increase the revenue of cities and municipalities by about thirty to fifty percent (30 to 50%) by mobilizing the barangay tanods in tax and revenue collections.
