A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR., TO ENTER INTO AN AGREEMENT BY AND BETWEEN THE QUEZON CITY GOVERNMENT AND MAYNILAD WATER SERVICES, INC. (MWSI) FOR THEIR BAYANIHAN PATUBIG PROGRAM AND OTHER WATER SERVICES PROJECTS.

WHEREAS, Maynilad Water Services, Inc., by virtue of the concession agreement with Metropolitan Waterworks and Sewerage System, has the sole right to manage, operate, repair, decommission and refurbish the facilities in the service area west which include parts of Quezon City,

WHEREAS, Maynilad Water Services, Inc. has programmed to improve the water facilities within its service area by laying down pipelines in various areas within the jurisdiction of Quezon City, among others the Bayanihan Patubig Project,


