A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR FELICIANO R BELMONTE, JR., TO ENTER INTO AN AGREEMENT $\mathbf{B}\mathbf{Y}$ AND BETWEEN THE QUEZON CITY GOVERNMENT AND MAYNILAD WATER SERVICES, INC. (MWSI) FOR THEIR BAYANIHAN PATUBIG PROGRAM AND OTHER WATER SERVICES PROJECTS.

WHEREAS, Maynilad Water Services, Inc., by virtue of the concession agreement with Metropolitan Waterworks and Sewerage System, has the sole right to manage, operate, repair, decommission and refurnish the facilities in the service area west which include parts of Quezon City,

WHEREAS, Maynilad Water Services, Inc. has programmed to improve the water facilities within its service area by laying down pipelines in various areas within the jurisdiction of Quezon City, among others the Bayanihan Patubig Project;

WHEREAS, the Quezon City government, which has jurisdiction over these project sites, and the Maynilad Water Services, Inc., have agreed to enter into an agreement which will embody the rights and obligations of both parties.
