A RESOLUTION STRONGLY URGING QUEZON CITY MAYOR FELICIANO R. BELMONTE, JR., TO GRANT FINANCIAL ASSISTANCE TO THE VICTIMS OF FIRE THAT OCCURRED ON JANUARY 26, 2005 AT PUROK II, LUZON AVENUE, BARANGAY CULIAT, QUEZON CITY COMPRISING OF FIFTY-NINE (59) FAMILIES, HOMEOWNERS/RENTERS/SHARERS AT TWO THOUSAND PESOS (P2,000.00) EACH IN THE TOTAL AMOUNT OF ONE HUNDRED EIGHTEEN THOUSAND PESOS (P118,000.00) TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUND OF THE CITY TREASURY.

WHEREAS, a fire occurred on January 26, 2005 at Purok II, Luzon Avenue, Barangay Culiata, this City rendering homeless fifty-nine (59) families, homeowners/renters/sharers;

WHEREAS, Section 458(1)(iv) of the Local Government Code of 1991 empowers the Sangguniang Panlungsod to "adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and to provide relief services and assistance for victims during and in the aftermath of said disaster or calamities and their return to productive livelihood following said events";


