RESOLUTION NO. SP- 2808, S-2005

A RESOLUTION STRONGLY PROPOSING THE INCLUSION IN THE QUEZON CITY SCHOOL BOARD BUDGET FOR SCHOOL YEAR 2005 – 2006 THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00) TO BE MADE AVAILABLE FOR THE ACQUISITION OF TWO (2) UNITS OF AIR CONDITIONERS TO BE USED AT THE LABORATORY SCIENCE ROOM OF THE LAGRO ELEMENTARY SCHOOL IN BARANGAY LAGRO, QUEZON CITY.


