A RESOLUTION EXTENDING THE CONTRACT OF SOLID WASTE COLLECTION, CLEANING AND DISPOSAL SERVICES AND OPERATION ENTERED INTO BY AND BETWEEN THE QUEZON CITY GOVERNMENT AND DODGE SERVICES CORPORATION, GREENLINE ONXY ENVIRONTECH, HALREY SERVICES, INC., OMNI HAULING SERVICES, INC., IPM CONSTRUCTION AND DEVELOPMENT, CARC ENTERPRISES, AND FCS TRANSPORT SERVICES FOR THE PERIOD FROM JANUARY 1 TO JUNE 30, 2005.


NOW, THEREFORE,
