A RESOLUTION URGING AND REQUESTING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR., FOR THE CONSTRUCTION OF A BASKETBALL COVERED COURT TO BE LOCATED IN AN OPEN SPACE LOCATED AT GARCIA STREET, DESCRIBED AS BLOCK 8, LOT 6, WITH AN AREA OF ONE THOUSAND SIX HUNDRED TWENTY-THREE SQUARE METERS (1,623 SQ. M), HOBART VILLAGE, BARANGAY KALIGAYAHAN, QUEZON CITY.



NOW, THEREFORE,


