RESOLUTION NO. SP. 2820 2005

A RESOLUTION URGING AND REQUESTING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR., FOR THE CONSTRUCTION OF A BASKETBALL COVERED COURT TO BE LOCATED IN AN OPEN SPACE LOCATED AT GARCÍA STREET, DESCRIBED AS BLOCK 8, LOT 6, WITH AN AREA OF ONE THOUSAND SIX HUNDRED TWENTY-THREE SQUARE METERS (1,623 SQ. M), HOBART VILLAGE, BARANGAY KALIGAYAHAN, QUEZON CITY.

WHEREAS, the Quezon City government, through the City Council, is empowered to grant the wishes of the Federation of Barangay Kaligayahan.
