RESOLUTION NO. SP- **2825**, 2005

A RESOLUTION URGING QUEZON CITY MAYOR FELICIANO R. BELMONTE, JR., TO GRANT FINANCIAL ASSISTANCE TO THE VICTIMS OF THE FIRE THAT OCCURRED ON FEBRUARY 5, 2005 AT NO. 604 QUIRINO HIGHWAY, BARANGAY BAGBAG, NOVALICHES, QUEZON CITY, COMPRISING OF EIGHTEEN (18) FAMILIES CONSISTING OF TEN (10) HOMEOWNERS AT TWO THOUSAND PESOS (P2,000.00) EACH, EIGHT (8) RENTERS/SHARERS AT ONE THOUSAND PESOS (P1,000.00) EACH, IN THE TOTAL AMOUNT OF TWENTY-EIGHT THOUSAND PESOS (P28,000.00) TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUND IN THE CITY TREASURY.

WHEREAS, a fire occurred on February 5, 2005 at No. 604 Quirino Highway, Barangay Bagbag, Novaliches, this City, rendering homeless eighteen (18) family-homeowners/renters/sharers;

WHEREAS, Section 458 (1) (iv) of the Local Government Code of 1991 empowers the Sangguniang Panlungsod to "adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events."


