RESOLUTION NO. SP- **2826** 2005

A RESOLUTION GRANTING BURIAL ASSISTANCE TO THE FAMILY AND SURVIVING HEIRS OF THE LATE KAGAWAD TERESITA B. CAMARO OF BARANGAY CULIAT, QUEZON CITY IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00) TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2005 ANNUAL BUDGET OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS IN THE CITY TREASURY.

WHEREAS, Barangay Kagawad Teresita B. Camaro of Barangay Culiat, this City, died last February 5, 2005;



Camaro of Barangay Culiati, Quezon City in the amount of Thirty Thousand Pesos (P30,000.00) to be charged against the appropriation for Grants, Subsidies and Contributions under the 2005 Annual Budget of the City Mayor or from any available funds in the City Treasury.
