RESOLUTION NO. SP- **2827**, S-2005

A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO PETRON CORPORATION FOR THE CONSTRUCTION AND OPERATION OF A GASOLINE SERVICE STATION LOCATED ALONG DAHLIA STREET CORNER LILAC STREET, BARANGAY FAIRVIEW, QUEZON CITY.

WHEREAS, petitioner Petron Corporation thru their Retail Trade Sales Director Mr. Wilfred R. Roldan, a duly registered business entity under Philippine laws is applying for the issuance of a Special Use Permit (SUP) for the construction and operation of a gasoline service station located along Dahlia Street corner Lilac Street, Barangay Fairview, Quezon City;

WHEREAS, gasoline service station are among the uses which requires a Special Use Permit upon authorization from the Quezon City Council as provided in Ordinance No. SP-918, S-2000, otherwise known as the Quezon City Comprehensive Zoning Ordinance of 2000;


WHEREAS, Petron Corporation has complied with the requirements for the issuance of a Special Use Permit as required by said Ordinance;
