RESOLUTION NO. SP- 2831, s-2005

A RESOLUTION AUTHORIZING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR TO AWARD THE PARCEL OF LAND LOCATED AT THE CORNER OF DOÑA JUANA RODRIGUEZ STREET AND E. RODRIGUEZ AVENUE, BARANGAY KALUSUGAN, QUEZON CITY TO BARANGAY KALUSUGAN IN WHICH THEIR BARANGAY STRUCTURE ONCE STOOD.

WHEREAS, the Barangay Council of Barangay Kalusugan is seeking an assistance from the City government to have their own property to build up/develop a barangay structure such as Barangay Hall, Reading Center, Chapel, Daycare Center, Health Center, Covered Court, SK Multipurpose Center, and Buy Back Center;

WHEREAS, the residents of the said barangay has express their full support to the move of the barangay by affixing their signature campaign for the favorable approval of the said project;

WHEREAS, the 15th City Council has passed a Resolution docketed as SP-2219, S-2003, appealing to MMDA to exempt in the demolition or clearing operation of the City street, of the existing barangay structure occupying part of the sidewalk of Barangay Doña Juana Rodriguez Street, Barangay Kalusugan, Quezon City.
