RESOLUTION NO. SP-2840 s-285

A RESOLUTION REQUESTING THE NATIONAL HOUSING AUTHORITY TO EXECUTE A DEED OF DONATION IN FAVOR OF THE QUEZON CITY GOVERNMENT TO EFFECT THE TRANSFER OF TITLE AND TURNOVER OF A PARCEL OF LOT COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBER 37216, WITH AN AREA OF SEVEN HUNDRED FORTY (740) SQUARE METERS LOCATED AT BLOCK 9, BCS 3169 AT BARANGAY STO. DOMINGO, QUEZON CITY, TO BE USED AS THE SITE OF THE MULTIPURPOSE HALL.

WHEREAS, there is a parcel of land owned by the National Housing Authority located in Barangay Sto. Domingo containing more or less One Thousand Three Hundred Twelve (1,312) Square Meters covered by Transfer Certificate of Title Number 37216;

WHEREAS, on September 16, 1999, the Authority allocated the Seven Hundred Forty Square Meters of the said lot for donation to the Quezon City government for the construction of a multi-purpose hall of Barangay Sto. Domingo, Quezon City;

WHEREAS, the City Planning and Development Office of Quezon City, favorably endorsed that a construction of the Barangay Multi-Purpose Hall is feasible;

WHEREAS, there is an urgent need to donate the said lot to pave the way for the construction of the multi-purpose hall for the benefit of the constituents/residents of Quezon City.
