A RESOLUTION AUTHORIZING THE CONVERSION OF A PORTION OF AN OPEN SPACE AT SOUTH GREEN PARK SUBDIVISION, BARANGAY TANDANG SORA AND DECLARING IT AS A ROAD LOT TO SERVE AS A PERMANENT ACCESS ROAD FROM MOLAVE STREET TO TREASURY STREET (SOUTH GREEN PARK VILLAGE) LEADING TO GENERAL AVENUE.

WHEREAS, an open space of South Green Park Village, Barangay Tandang Sora, is adjacent to Treasury Street, which is a dead end street, located at the GSIS Village;

WHEREAS, the conversion and improvement of a portion of the open space into a road lot and Treasury Street were undertaken by the South Green Park Village Homeowners Association due to the urgent need for entrance and exit to General Avenue;

WHEREAS, the improvement of Treasury Street (dead end), will serve as deterrent in the commission of crimes, such as bag snatching, molestermashers and pot sessions of drug addicts in the area;
