A RESOLUTION AUTHORIZING THE ISSUANCE OF CERTIFICATE OF EXEMPTION TO LAND BANK OF THE PHILIPPINES FOR THE CONSTRUCTION OF A THREE STOREY LAND BANK BRANCH OFFICE BUILDING LOCATED AT LOT 9B BLOCK W-22, WEST AVENUE, BARANGAY BUNGAD, QUEZON CITY.
