WHEREAS, Atty. Baylon has already served as a Chief of Staff of a Congressman in the Commission of Appointments, a position with an Undersecretary level;

WHEREAS, Atty Baylon is a holder of the Third Level Eligibility or the Civil Service Executive Eligibility conferred by the Civil Service Commission, eligibility not all lawyers possess;

WHEREAS, Atty. Baylon has been actively participating in community building projects in Quezon City as a member of the Quezon City Capitol Jaycees;

WHEREAS, Atty. Baylon's credibility and morality are unquestionable being a members of various Church organizations such as the Knights of Columbus, the Parish Renewal Experience (PREX), and the Parish Pastoral Council of St. Paul's Parish Church in Quezon City;
