RESOLUTION NO. SP- 2867, S-2005

A RESOLUTION EXTENDING FINANCIAL ASSISTANCE TO THE ONE THOUSAND (1,000) FAMILIES WHOSE HOUSES WERE BURNED BY FIRE AT THE STREETS OF ACACIA, MANGGA, ALCOY AND HONA, OF SITIO SAN ROQUE, BARANGY BAGONG PAG-ASA, QUEZON CITY ON MARCH 6, 2005 AT AROUND THREE O'CLOCK IN THE AFTERNOON, AT THE SUM OF TWO THOUSAND PESOS (P2,000.00) PER FAMILY OWNER, AND ONE THOUSAND PESOS (P1,000.00) PER FAMILY RENTER/SHARER, AND ALLOCATING THE AMOUNT NECESSARY TO BE TAKEN FROM THE CALAMITY OR EMERGENCY FUND OF THE CITY GOVERNMENT OR FROM ANY AVAILABLE FUNDS IN THE CITY TREASURY.

WHEREAS, the Quezon City Council is empowered under Section 458 (a), (f), (iv) of RA 7160, otherwise known as the Local Government Code of 1991, to "adopt measures to protect the inhabitants of the City from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events";

WHEREAS, an unfortunate event occurred in the afternoon of March 6, 2005, as fire gutted the streets of Acacia, Mangga, Alcoy, and Hona of Sitio San Roque, Barangay Bagong Pag-asa, Quezon City, affecting One Thousand (1,000) families;


WHEREAS, the unfortunate victims need the assistance of the City government in the form of financial aid to defray the cost of building materials for the reconstruction of their houses, purchase of food and clothing, and other necessary expenses in the amount of two thousand pesos (P2,000.00) for each owner and one thousand pesos (P1,000.00) for each house renter/sharer.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to extend, as it does hereby extend, financial assistance to the one thousand (1,000) families affected by the fire that occurred in the streets of Acacia, Mangga, Alcoy and Hona of Sitio San Roque, Barangay Bagong Pag-asa, District I, Quezon City, at the sum of Two Thousand Pesos (P2,000.00) per family owner and One Thousand Pesos (P1,000.00) per family renter/sharer, and allocating the amount necessary to be taken from the calamity or emergency fund of the city government or from any available funds in the City Treasury.


