## RESOLUTION NO. SP- 2878, 1005

A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO DIGITEL TELECOMMUNICATIONS PHILIPPINES, INC. (DIGITEL) THROUGH ITS AUTHORIZED REPRESENTATIVE MR. JURGEN A. DAWINAN, SAQ & PERMITING OFFICER, LEBLANC COMMUNICATION PHILIPPINES FOR THE CONSTRUCTION AND OPERATION OF CELL SITES AT TWO LOCATIONS, ALL IN QUEZON CITY.

Introduced by Councilors ANTONIO E. INTON, JR., BERNADETTE HERRERA-DY, JOSEPH P. JUICO and ERIC Z. MEDINA.

WHEREAS, the Digital Telecommunications Philippines, Inc. (DIGITEL) is applying for a Special Use Permit for the Construction and Operation of Cell Sites located at two locations, all in Quezon City, to wit:


- Capitol Homes Water Tank Bonn Ave., Capitol Homes Subdivision, Barangay Old Balara, Quezon City.
- 2. St. Lukes College of Medicine Bldg. St. Ignacia St., Barangay Kalusugan, Quezon City.

WHEREAS, ALCATEL Philippines, Inc., being the general contractor of DIGITEL, has authorized the LeBLANC Communications Philippines, Inc., to apply and transact for the Special Use Permit and other necessary permit for the installation and operation of the above mentioned cell sites;

WHEREAS, the operation of the said Cell Sites will serve to promote public welfare and economic development through the projected increase of employment opportunity and business opportunity in Quezon City;

WHEREAS, in accordance with the provision of Article VII, Section 2 (h) Ordinance No. SP-918, S-2000, and its implementing rules and regulation, a special use permit is required for Cell Sites to which the proposed project falls under.
