RESOLUTION NO. SP-**2880**, S-2005

A RESOLUTION REQUESTING HER EXCELLENCY, PRESIDENT GLORIA MACAPAGAL-ARROYO, TO ISSUE AN EXECUTIVE ORDER EXEMPTING THE QUEZON CITY GOVERNMENT FROM THE ACQUISITION OF ENVIRONMENTAL CERTIFICATE OF CLEARANCE FOR THE CONSTRUCTION AND DEVELOPMENT OF INTEGRATED SOLID WASTE MANAGEMENT DISPOSAL PROJECT SITE OUTSIDE QUEZON CITY PURSUANT TO REPUBLIC ACT NO. 9003.

Introduced by Councilors ERIC Z. MEDINA, ANTONIO E. INTON, JR., RESTITUTO B. MALAÑGEN, BERNADETTE HERRERA-DY and RAMON P. MEDALLA.

WHEREAS, the Payatas Dumpsite will be phased out in the next few years;

WHEREAS, the Quezon City government will encounter uncontrollable waste-disposal that will be disastrous to its ecological atmosphere as well as endanger the health of the constituents;

WHEREAS, in addressing the anticipated problem, the City Council approved Proposed Resolution No. 123, S-2004 xxx urging the City Mayor, Honorable Feliciano R. Belmonte, Jr., and Environmental Protection and Waste Management Department (EPWMD) to conduct a study on the possible alternative Solid Waste Management Program for Quezon City xxx;

WHEREAS, in order to establish the construction, development and operations of Waste and Management Disposal System, an Environmental Certificate Clearance from the Department of Environment and Natural Resources is required by law;

WHEREAS, due to the urgency of the matter, it is Her Excellency, President Gloria Macapagal-Arroyo, who could issue an Executive Order exempting the local government of Quezon City to secure said Environmental Certificate Clearance.
