RESOLUTION NO. SP-2883, S-2005

A RESOLUTION URGING THE CITY MAYOR, HONORABLE FELICIANO R. BELMONTE, JR., TO ALLOCATE THE NECESSARY FUNDS FOR THE CONSTRUCTION OF A CITY GOVERNMENT-OWNED COLUMBARIUM IN AN APPROPRIATE LOCATION TO BE DETERMINED BY THE QUEZON CITY GOVERNMENT TO BE CHARGED AGAINST THE 2005 ANNUAL BUDGET OF THE QUEZON CITY GOVERNMENT.

WHEREAS, Ordinance No. SP-1400, S-2004 provides for the construction of one City government-owned crematorium in view of the limited burial grounds to use and operate as cemeteries;

WHEREAS, said ordinance does not provide for any provision establishing or constructing a structure or place intended to be used as compartments for the ashes of cremated bodies;

WHEREAS, corollary to this mandate, it is necessary for the City government of Quezon City to construct a City government-owned columbarium so as to accommodate the ashes of cremated bodies;

WHEREAS, the whole of Quezon City has no city government-owned columbarium;

WHEREAS, number of residents in Quezon City necessitates the construction of one Government-Owned Columbarium in as much as it is widely accepted and considered as a convenient and practical way of accommodating our departed love ones.




NOW, THEREFORE,
