A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR., TO DISPOSE BY WAY OF DIRECT SALE OF A PARCEL OF LAND DESCRIBED IN TRANSFER CERTIFICATE OF TITLE NUMBER RT-57558 (265243) CONSISTING OF FIVE THOUSAND ONE HUNDRED FORTY TWO (5,142) SQUARE METERS SITUATED AT M. AQUINO ST., BARANGAY STA. LUCIA, QUEZON CITY, TO BONAFIDE OCCUPANTS/MEMBERS OF THE SAMAHANG MELCHORA AQUINO NEIGHBORHOOD ASSOCIATION (SAMANA) IN BARANGAY STA. LUCIA, QUEZON CITY, AT A SELLING PRICE OF P1,000.00 PER SQUARE METERS.

WHEREAS, the above-mentioned beneficiaries of said socialized project has appealed for the disposal of the above-mentioned property thru direct sale at the price of One Thousand Pesos (P1,000.00) per square meters, taking into consideration of the capacity to pay of the beneficiaries since most of them are low-income earners;
