## RESOLUTION NO. SP-2889 S-2005

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR., QUEZON CITY, TO NEGOTIATE FOR THE PURCHASE OF A 1.6 HECTARE PROPERTY AT SITIO PAJO, BARANGAY BAESA, QUEZON CITY, OWNED BY THE NATIONAL POWER CORPORATION (NAPOCOR) AT EIGHT HUNDRED PESOS (P800.00) PER SQUARE METER FOR THE PURPOSE OF CONSTITUTING A HOUSING PROJECT TO QUALIFIED BENEFICIARIES IN THE AREA.

WHEREAS, Executive Order No. 58, issued by President Gloria Macapagal Arroyo, authorizes the National Power Corporation (NAPOCOR) to dispose of its 1.6 hectare property located in Sitio Pajo, Barangay Baesa, Quezon City to its bonafide occupants;

WHEREAS, a Memorandum of Agreement between NAPOCOR and the Samahang Sitio Pajo 1.6 Hectare Homeowners Association was prepared and the manner of disposition was thru the Community Mortgage Program (CMP) to be originated by the Foundation for Development Alternative (FDA), a non-government organization;

WHEREAS, because of several reasons, the originator (FDA) backed out of the Project, the occupants turned to the City government to resolve the current problems;

WHEREAS, while the City government is taking in-charge of the matter, the City government find it unreasonable to pursue the disposition thru CMP because the lots to be generated are only 328 while the actual occupants are more than 700 families, more than half would be displaced thereby creating another problem in terms of relocation.
