RESOLUTION NO. SP- 2894, 2005

A RESOLUTION GRANTING AUTHORITY TO IGLESIA NI CRISTO TO CONSTRUCT THE IGLESIA NI CRISTO CHURCH AT VETERANS VILLAGE, BARANGAY HOLY SPIRIT, QUEZON CITY.

Introduced by Councilors WINSTON "Winnie" T. CASTELO, ANTONIO E. INTON, JR., VOLTAIRE GODOFREDO L. LIBAN III, ROMMEL R. ABESAMIS, ERIC Z. MEDINA, JORGE B. BANAL, JR., BAYANI V. HIPOL and RESTITUTO B. MALAÑGEN.

WHEREAS, the Iglesia ni Cristo is one of the predominant religion which is highly respected worldwide;

WHEREAS, Article III Section 5 of the 1987 Constitution provides that "No law shall be made respecting an establishment of religion, or prohibiting the free exercise thereof. The free exercise and enjoyment of religious profession and worship without discrimination or preference shall forever be allowed";

WHEREAS, the Iglesia ni Cristo has four (4) parcels of land located at Veterans Village, Barangay Holy Spirit, Quezon City, covered by Transfer Certificates of Title Numbered N-205392, N-204923 and N-204921, with a total area of One Thousand Six Hundred Square Meters (1,600 sq. m.), is being proposed for the construction of a church for their congregation;

WHEREAS, said parcels of land are located within a zone classified as (R-2) Medium Density Residential Zone per Ordinance No. SP-918, S-2000, wherein construction of church is allowable;


WHEREAS, Barangay Holy Spirit, Quezon City, under their Barangay Council Resolution No. 172, S-2005, has granted clearance to Iglesia Ni Cristo to construct a church located at Veterans Village.

NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Iglesia ni Cristo to construct the Iglesia ni Cristo Church at Veterans Village, Barangay Holy Spirit, Quezon City.
