RESOLUTION NO. SP-2904 S-2005

A RESOLUTION URGING HIS HONOR, CITY MAYOR FELICIANO R. BELMONTE, JR., TO PURCHASE LOT 17 AND LOT 19 BLOCK 373 BOTH HAS AN AREA OF FOUR HUNDRED TWENTY SQUARE METERS (420 SQ. M.) LOCATED AT TENDIDO ST. BARANGAY SAN JOSE AND TO CONSTRUCT A MEDIUM RISE BUILDING THEREOF FOR THE CONSTITUENT RENTERS AS PART OF BARANGAY SAN JOSE SOCIALIZED HOUSING PROJECT OF THE CITY GOVERNMENT.

WHEREAS, according to the report of Urban Poor Affairs Office Lot 17 with TCT No. RT- 40815 and Lot 19 of block 373 located in Tendido Street, Quezon City, are feasible for Medium Rise Building for the constituents renters of Brgy. San Jose Project;

WHEREAS, the owner/ heirs Amelia B. Maramara and Benjamin Maramara offered to sell the said lot including the existing apartment for a price of Twelve Million (PhP12,000,000.00) Pesos to the Quezon City government.
