RESOLUTION NO. SP-**2906**s-2005

A RESOLUTION GRANTING FINANCIAL ASSISTANCE IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00) TO THE BEREAVED FAMILY OF THE LATE LUIS D. MATREO, FORMER BARANGAY KAGAWAD, BARANGAY BAGONG SILANGAN, QUEZON CITY, WHO DIED ON MAY 6, 2000, CHARGEABLE AGAINST THE APPROPRIATIONS FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2005 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.

WHEREAS, the late kagawad Luis D. Matreo had served Barangay Bagong Silangan, Quezon City from 1997 to 2000;

WHEREAS, during his incumbency, he was instrumental in various projects in their barangay that are still being enjoyed by the inhabitants;

WHEREAS, in recognition of his unparalleled public service and in support to his family who suffered a bleak future because of his untimely demise, the City government should extend financial assistance to his bereaved family.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to grant, as it does hereby grant, financial assistance in the amount of Thirty Thousand Pesos (P30,000.00) to the bereaved family of the late Luis D. Matreo, former Barangay Kagawad, Barangay Bagong Silangan, Quezon City, who died on May 6, 2000, chargeable against the appropriations for grants, subsidies and contributions under the 2005 annual budget of the Office of the City Mayor or from any available funds of the City Treasury.
