A RESOLUTION URGING HER EXCELLENCY GLORIA MACAPAGAL-ARROYO THRU THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) FOR THE COMPLETION OF THE CONCRETING OF COMMONWEALTH AVENUE EXTENSION IN NOVALICHES, QUEZON CITY, THAT WOULD SERVE AS AN ALTERNATIVE ROUTE TO QUIRINO HIGHWAY.

WHEREAS, it is the policy of the state to give emphasis to the worsening problem of traffic congestion in the metropolis;

WHEREAS, the development and extension of Commonwealth Avenue to Quirino Highway, Novaliches, would decongest traffic bottleneck in the area as this would serve as an alternative route for all vehicles;

WHEREAS, the completion of the concreting of Commonwealth Avenue Extension in Novaliches will enhance the development of the northern portion of Novaliches area;

WHEREAS, considering that the completion of Commonwealth Avenue has been in the planning stage for a long time, it is imperative that full implementation of said project be now given due course in order to decongest the traffic situation in the area, at the same time provide better access to nearby barangays in Novaliches area.
